MEMORANDUM

TO: All Local HBA Executive Officers and Elected Secretaries

RE: 2014 Officers, State Directors and Committee Chairpersons

Enclosed please find the forms to use in registering your Local Officers, State Directors and Committee Chairpersons with NCHBA. **It is very important that you send this information to us NO LATER THAN Friday, December 27, 2013!** This is the first link in a chain of information we need in order to keep our communication lines open with you.

We need to know who your incoming president will be and who will serve as Executive Officer or Elected Secretary in 2014. ***Your local association president, who should be a builder member, is automatically a State Director.***

In addition, your association is entitled to elect State Directors and Alternate State Directors in proportion to its builder membership. Please review Article VII, Section 2, (A) of the NCHBA By-Laws in order to determine the number of State Directors you are allowed. **According to the NCHBA bylaws, your builder membership, as of August 31 of the preceding year in which the directors will serve, determines the number of directors entitled to serve from your local HBA.** For example, if you have 50 builder members as of August 31, 2013, your HBA is entitled to 2 state directors who will serve on the 2014 NCHBA Board of Directors. If you have any questions regarding this policy, please feel free to call the NCHBA office.

A copy of the Membership Summary as of August 31, 2013 and a copy of Article VII of the NCHBA By-Laws are enclosed for your convenience. Article VII, Section 3 of the By-Laws addresses the "Tenure of Office". **As you will notice, we have extended the deadline for notification from November 1 to December 27, 2013.**

ARTICLE VII

Board of Directors

Section 1. The governing body of this Association shall be a Board of Directors which shall conduct the general affairs of this Association subject to the rights and powers of the general membership; shall elect officers of the Association; shall administer the finances of the Association; and, shall have sole authority to appropriate money. A majority of the Directors holding office at any time shall be builder members.

Section 2. Composition of the Board of Directors shall be determined in the following manner:

→ (A) Each affiliated local association shall be entitled to one State Director who shall be the local association president, who shall be a builder member, and also entitled to elect additional State Directors and alternate State Directors in proportion to its builder membership as follows (based on builder membership on August 31 of each year):

Builder Membership	Elected Directors	Alternate Directors	Total Voting Directors
1. up to 25	One (1)	One (1)	Two (2) – <i>includes one director and local president</i>
2. 26 to 75	Two (2)	Two (2)	Three (3) – <i>includes two directors and local president</i>
3. 76 or more	Three (3)	Three (3)	Four (4) – <i>includes three directors and local president</i>

To insure that builder members shall constitute a majority of the Board of Directors, each local association entitled to elect two (2) or more directors (exclusive of the local association President who shall be a builder member) shall elect at least one (1) builder member to serve as a State Director.

(B) There shall be at least one Director-at-large for each group of twenty-five (25) or fractional part thereof, who are builder members of this Association, but not members of any affiliated local association. These Directors-at-large shall be elected by the Board of Directors of the State Association.

(C) The Board of Directors shall nominate member(s) as authorized by the National Association to serve as National Director(s) and Alternate National Director(s); one builder member to serve as the State Representative from the Association; and one builder member to serve as NAHB Executive Board ASpecial Voting Member@ whenever North Carolina is entitled to that position. The Associate Member Director is limited to two consecutive one year terms.

(D) The President; President-Elect; First Vice-President; Regional Vice-Presidents; Secretary/Treasurer; Immediate Past President; Chairperson, Associate Members' Committee; the President of the N.C. Professional Women in Building; and the three (3) presidential appointees to the Executive Committee shall be members of the Board of Directors with the right to vote.

(E) The Past Presidents of NCHBA shall be lifetime ex-officio members of the Board of Directors with the right to vote provided that any Past President who serves as a member of the Board of Directors of Builders Mutual Insurance Company shall, upon his or her election to that Board, be removed and disqualified from serving as a member of the NCHBA Board of Directors, except that the Immediate Past President shall not be disqualified until the expiration of his or her term of office as the Immediate Past President. Upon ceasing to serve as a member of the Board of Directors of Builders Mutual Insurance Company, the lifetime ex-officio membership status of the Past President conferred by this subsection shall be automatically restored.

(F) The President of the EO/ES Council and the Executive Vice-President of NCHBA shall be ex-officio members of the Board of Directors, without the right to vote.

→ Section 3. Tenure of Office - Directors shall be elected by local associations for a term of one year. Such term is to commence January 1 of each year. The NCHBA Secretary/Treasurer must be notified by November 1 of each year of the Directors for the upcoming year. If no notification is received, the current Directors will be carried forward for a period not to exceed twelve (12) months. In the event there are no new Directors elected and reported as set forth in this section, the local association will be represented only by their President. The Secretary/Treasurer must be notified thirty (30) days prior to a Board of Directors meeting of any changes or additions in Directors.

Section 4. Vacancies - A vacancy occurring on the Board of Directors shall be filled in the same manner as the original appointment.

What is a NC BUILD-PAC Trustee?

Each local association has a trustee who sits on the NC BUILD-PAC Board of Trustees. This Board approves contributions given to candidates for statewide office and the NC General Assembly.



How/When does a Trustee get nominated?

Each year around November, each local EO receives a memo with a nomination form to pick their Local Officers, State Directors, Committee Chairpersons, President and NC BUILD-PAC Trustee. This form is sent back to NCHBA and registered in our database until the new nominations are sent the following year. Trustees are typically appointed by the local HBA President to serve for that year.

Who makes a good Trustee?

When appointing a trustee you should choose a person who has an interest in state and local politics, is an active member of your association, a NC BUILD-PAC contributor, someone who is able to attend NC BUILD-PAC Board of Trustee's meetings and who is not afraid to ask for money! This does not mean they have to follow what is happening with every candidate in every election or even understand all aspects of politics, but just have the desire to learn or become more involved.

What does a Trustee do?

NC BUILD-PAC Trustees should be available to attend quarterly meetings and special meetings prior to primary and general elections. This is so your Trustee can recommend and relay information about candidates in their area so the NC BUILD-PAC Board of Trustee's can make an informed decision. It is also crucial for the Trustee to relay any important information back to their EO and local association.

The Trustee will also receive the monthly reports with the local reserve amounts and funds raised by their association. It is their job to educate members about the importance of NC BUILD-PAC and why it is significant to our success as an industry. The reports let them know where they stand each month compared to other associations and their goal progress.
