

AK HB 259

Title: "An Act establishing the Council on Human and Sex Trafficking; and relating to the

Council on Domestic Violence and Sexual Assault."

Summary: This bill establishes the Council on Human and Sex Trafficking in the Department of Public Safety in Alaska. The purpose of the council is to coordinate programs related to

victim services, education, public awareness, data collection, and reducing demand for human and sex trafficking. The council's duties include developing and implementing a standardized data collection system on human and sex trafficking, dispensing state and federal money and awarding grants and contracts to qualified local community entities for intervention and prevention programs, overseeing and auditing these entities, coordinating and consulting with other state agencies and community entities working on human and sex trafficking, and conducting public hearings and creating opportunities for public input on these issues.

Summary: This is an appropriations bill. Suicide Prevention Council receives \$608,700 from general and other funds. Children's Services receives \$2,711,900 from general and other funds. These funds are distributed varyingly between Children's Services Management, Front Line Social Workers, Family Preservation, Foster Care Augmented Rate, and Foster Care Special Need.

Title: Teen suicide awareness special plates

Summary: This bill adds a new section to establish teen suicide awareness special plates. If a person pays \$32,000 to the Department of Transportation by December 31, 2024, the

department shall issue teen suicide awareness special plates. The design and color of the plates are subject to department approval.

Title: Pupil health: suicide prevention policies: pupil mental health crisis.

Current Status: In Senate

Introduction Date: 2024-02-16

Last Action Date: Set for hearing April 3.. 2024-03-20

Summary: This bill would amend existing law related to pupil health, specifically suicide prevention policies and pupil mental health crisis intervention in educational settings. The bill would require local educational agencies to adopt policies addressing crisis intervention protocols in cases of pupil mental health crises, limiting the involvement of law enforcement to situations of imminent danger to the pupil's life. The bill also outlines the process for informing parents or guardians of pupils experiencing mental health crises. Furthermore, the bill mandates that agencies review their suicide prevention policies at least every fifth year and update them to incorporate best practices identified by the Department of Education. The bill also encourages agencies without mental health professionals to consider redirecting funding to hiring such professionals. The bill includes specific provisions regarding suicide prevention policies for different grade ranges, mandates training for teachers on suicide awareness and prevention, and sets deadlines for policy revisions and updates. If the Commission on State Mandates determines that the bill imposes costs on local agencies, reimbursement shall be made accordingly.

Description: SB 1318, as amended, Wahab. Pupil health: suicide prevention policies: pupil mental health crisis. Existing law requires the governing board or body of a county office of education, school district, state special school, or charter school that serves pupils in kindergarten and grades 1 to 12, inclusive, to adopt a policy on pupil suicide prevention that specifically addresses, among other things, procedures relating to suicide prevention, intervention, and postvention, and any training on suicide awareness and prevention to be provided to teachers of pupils in all of the grades served by the local educational agency. Existing law requires the governing board or body of a local educational agency that serves pupils in kindergarten and grades 1 to 12, inclusive, to review, at minimum every 5th year, its policy on pupil suicide prevention and, if necessary, update its policy. This bill would require, on or before July 1, 2026, the policy to also address crisis intervention protocols that local educational agencies are required to follow in the event of a pupil mental health crisis, as defined, including the process by which staff and external agencies are deployed to address a pupil mental health crisis, limiting the involvement and notification of law enforcement to situations in which a pupil's life is in imminent danger and their needs cannot be addressed by a mental health professional, and the process for informing the parent or guardian of the

pupil experiencing the mental health crisis, as provided. The bill would require, at each meeting of the governing board or body of a local educational agency when the governing board or body reviews its policy on pupil suicide prevention, if the local educational agency does not have a school mental health professional, the governing board or body to discuss whether funding should be identified for purposes of hiring a school mental health professional. By imposing additional duties on local educational agencies, the bill would impose a state-mandated local program. The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement. This bill would provide that, if the Commission on State Mandates determines that the bill contains costs mandated by the state, reimbursement for those costs shall be made pursuant to the statutory provisions noted above.

CASB 1397

Title: Behavioral health services coverage.

Current Status: In Senate

Introduction Date: 2024-02-16

Last Action Date: From committee with author's amendments. Read second time and

Summary: This bill aims to ensure that healthcare service plans and health insurers provide coverage for behavioral health crisis services, including services provided by 988 centers, mobile crisis teams, and other providers. This bill would authorize a county to report to the Department of Managed Health Care or the Department of Insurance a complaint about a health care service plan's or a health insurer's failure to make a good faith effort to contract or enter into an agreement with the county to obtain reimbursement for behavioral health crisis services, or to timely reimburse the county for services the plan or insurer is required to cover by state or federal law, and would require the respective department to timely investigate the complaint.

Description: SB 1397, as amended, Eggman. Behavioral health services coverage. Existing law, the Knox-Keene Health Care Service Plan Act of 1975, provides for the licensure and regulation of health care service plans by the Department of Managed Health Care and makes a willful violation of the act a crime. Existing law provides for the regulation of health and disability insurers by the Department of Insurance. Existing law requires a health care service plan contract or disability insurance policy to provide coverage for medically necessary treatment of mental health and substance use disorders. This bill would require a health care service plan contract or health insurance policy issued, amended, renewed, or delivered on or after July 1, 2025, that covers medically necessary mental health and substance use disorder services to comply with rate and timely reimbursement

requirements for services delivered by a county behavioral health agency, as specified. Unless an enrollee or insured is referred or authorized by the plan or insurer, the bill would require a county behavioral health agency to contact a plan or insurer before initiating services. The bill would authorize a plan or insurer to conduct a postclaim review to determine appropriate payment of a claim, and would authorize the use of prior authorization as permitted by the regulating department. The bill would require the departments to issue guidance to plans and insurers regarding compliance with these provisions no later than April 1, 2025. Because a willful violation of these provisions by a health care service plan would be a crime, and the bill would impose a higher level of service on a county behavioral health agency, this bill would impose a state-mandated local program. The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement. This bill would provide that, with regard to certain mandates, no reimbursement is required by this act for a specified reason. With regard to any other mandates, this bill would provide that, if the Commission on State Mandates determines that the bill contains costs so mandated by the state, reimbursement for those costs shall be made pursuant to the statutory provisions noted above.

Title: Pupil and student safety: identification cards: federal Title IX assistance telephone number.

Summary: This bill would, commencing July 1, 2025, require a public school, including a charter school, or a private school, that serves pupils in any of grades 7 to 12, inclusive, that issues pupil identification cards, and a public or private institution of higher education that issues student identification cards, to additionally have printed on the identification cards the telephone number for the United States Department of Education Office for Civil Rights for assistance related to Title IX.

Description: SB 1378, as introduced, Min. Pupil and student safety: identification cards: federal Title IX assistance telephone number. Existing law requires a public school, including a charter school, or a private school, that serves pupils in any of grades 7 to 12, inclusive, that issues pupil identification cards, and a public or private institution of higher education that issues student identification cards, to have printed on the identification cards the telephone number for the National Suicide Prevention Lifeline and the National Domestic Violence Hotline, and authorizes those schools to have printed on the identification cards certain other suicide-prevention and emergency-response telephone numbers. This bill

would, commencing July 1, 2025, require a public school, including a charter school, or a private school, that serves pupils in any of grades 7 to 12, inclusive, that issues pupil identification cards, and a public or private institution of higher education that issues student identification cards, to additionally have printed on the identification cards the telephone number for the United States Department of Education Office for Civil Rights for assistance related to Title IX.

CA AB 2052

Title: School-Based Health and Education Partnership Program.

Current Status: In Assembly Introduction Date: 2024-02-01

Last Action Date: Referred to Coms. on HEALTH and ED., 2024-02-12

Summary: This bill establishes the School-Based Health and Education Partnership Program in California. The bill amends existing law to require the State Department of Public Health to collaborate with the Office of School-Based Health Programs within the State Department of Education to award grant funding to applicants. The bill also revises the preferred recipients for funding, giving preference to school-based health centers serving schools in which more than 55% of pupils serviced are unduplicated pupils or areas experiencing health disparities in child and adolescent access to primary care, behavioral health, preventative health, or oral health services. The bill establishes procedures and requirements for school health centers receiving grant funding, including the provision of comprehensive services such as medical, oral health, mental health, and health education. School health centers must work in partnership with the school nurse, if available, and have written contracts or memoranda of understanding with health care providers and community organizations. The bill also outlines criteria for planning grants, facilities and startup grants, and sustainability grants. The Department of Public Health, in collaboration with the Office of School-Based Health Programs, will develop a request for proposal process for collecting information on applicants and determining which proposals will receive grant funding.

Description: AB 2052, as introduced, Jones-Sawyer. School-Based Health and Education Partnership Program. Existing law requires the State Department of Public Health, in cooperation with the State Department of Education, to establish a Public School Health Center Support Program to assist health centers in schools and school districts. Existing law requires the State Department of Public Health, subject to an appropriation, to establish a grant program to provide funding for, among other things, expansion, renovation, and retrofitting of existing school health centers. Existing law requires the State Department of Public Health to develop a request for proposal process in order to collect information on applicants and determine which proposals shall receive funding. Existing law requires the

State Department of Public Health to give preference to, among others, schools with a high percentage of low-income and uninsured children and youth or schools with a shortage of health professionals. This bill would instead require the State Department of Public Health to collaborate with the Office of School-Based Health Programs within the State Department of Education in order to award grant funding to applicants. This bill would revise and reorganize the above-described preferred recipients and give preference to school-based health centers serving, among others, schools in which more than 55 percent of pupils serviced are unduplicated pupils, as defined, or areas experiencing health disparities in child and adolescent access to primary care, behavioral health, preventative health, or oral health services.

CT SB 141

Title: AN ACT CONCERNING THE EXPANSION OF THE CRISIS INITIATIVE PILOT PROGRAM

THROUGHOUT THE STATE.

Current Status: In Senate
Introduction Date: 2024-02-15

Last Action Date: File Number 14 (LCO). 2024-03-13

Summary: This bill aims to expand the pilot program known as the CRISIS Initiative throughout the state. The Division of State Police, in collaboration with the Department of Mental Health and Addiction Services, is required to expand this program by January 1, 2025. The expanded program must include training for state police officers, coordination

between state police officers and mental health professionals, and referrals to mental health facilities. The purpose of this bill is to ensure that the CRISIS Initiative is implemented statewide. There is no information provided about any specific impacted business industries or monetary impacts associated with this bill. However, the expansion of the pilot program may have resource implications for the Division of State Police and the Department of Mental Health and Addiction Services.

Description: To require the Division of State Police to expand the CRISIS Initiative pilot program to all areas of the state.

FL SB 7016

Title: Health Care

Current Status: Enacted

Introduction Date: 2023-12-13

Last Action Date: Chapter No. 2024-15. 2024-03-22

Summary: This bill focuses on various amendments and additions to healthcare-related statutes. It defines a "mobile crisis response service" or "mobile response team" as a nonresidential behavioral health crisis service that operates 24/7, offering immediate intensive assessments and interventions, including screening for admission into mental health receiving facilities, addictions receiving facilities, or detoxification facilities, to identify suitable treatment services. The department is tasked with establishing rules outlining minimum standards for services provided by mental health overlay programs or mobile crisis response services. These standards for mobile crisis response services must include requirements for child, adolescent, and young adult mobile response teams, ensuring coverage across all counties. Additionally, they must establish a structure for general mobile response teams focusing on crisis diversion and reducing involuntary commitments. This structure should encompass triage and rapid crisis intervention, provision of evidence-based services, screening and assessment, and ensuring connection to service providers and medication if required.

Description: Revising the purpose of the Dental Student Loan Repayment Program; requiring the Department of Health to implement the Dr. and Mrs. Alfonse and Kathleen Cinotti Health Care Screening and Services Grant Program for a specified purpose; providing requirements for birth centers designated as advanced birth centers with respect to operating procedures, staffing, and equipment; requiring advanced birth centers to enter into a written agreement with a blood bank for emergency blood bank services; authorizing certain psychiatric nurses to order emergency treatment of certain patients; creating the Training, Education, and Clinicals in Health (TEACH) Funding Program for a specified purpose; enacting the Interstate Medical Licensure Compact in this state, etc.

Title: Solutions for Mental Health Professional Shortages

Current Status: Failed

Introduction Date: 2023-10-10

Last Action Date: Died in Health Policy. 2024-03-08

Summary: This bill establishes a Mental Health Profession Scholarship and Loan

Forgiveness Program within the department. Its goal is to attract capable students to mental health professions and encourage qualified professionals to work in areas with critical shortages. Scholarships are granted for up to two years, not exceeding \$8,000 annually, and may be adjusted based on the Consumer Price Index. Recipients must commit to providing mental health services in underserved areas or working in faculty positions after graduation. Those who fail to meet their obligations must repay the scholarship with interest. Loan repayment awards are also available for graduates in mental health professions, with the state making principal repayments for up to four years, contingent on continued employment in eligible healthcare facilities. The program prioritizes different types of employers, and its implementation is subject to specific funding. Rules will be adopted to address exceptional circumstances leading to default.

Description: Establishing a mental health profession scholarship and loan forgiveness program within the Department of Health for a specified purpose; providing for applicant eligibility and the award of scholarships; specifying service obligations for scholarship recipients; providing for applicant eligibility and the award of loan repayments, etc.

FL SB 792

Title: Community-based Mobile Crisis Intervention Services

Current Status: Failed

Introduction Date: 2023-12-07

Last Action Date: Died in Health Policy. 2024-03-08

Summary: This bill aims to extend Medicaid coverage to include community-based mobile crisis intervention services for Medicaid recipients. The agency is tasked with developing a plan for this coverage by January 1, 2025, consulting various relevant entities before seeking federal approval and waivers necessary for the plan's implementation. These entities include the Department of Children and Families, Department of Education, local governments, law enforcement agencies, school districts, managing entities, and managed care plans. The agency must adopt rules to enforce this section, and the act is set to take

effect on July 1, 2024, contingent upon funding availability and directions in the General Appropriations Act.

Description: Requiring the Agency for Health Care Administration to provide coverage for community-based mobile crisis intervention services for Medicaid recipients, subject to the availability of funds and specified limitations or directions; requiring the agency to perform certain duties by a specified date, including seeking federal approval and waivers for such coverage, etc.

FL HB 5001

Title: General Appropriations Act **Current Status:** Passed Senate **Introduction Date:** 2024-02-01

Last Action Date: Ordered enrolled. 2024-03-08

Summary: This is an appropriations bill. It allocates \$500,000 to Citrus Health Network - Crisis Stabilization Units (HF 2527). Additionally, it allocates \$250,000 to Clay Behavioral Health Center - Community Crisis Prevention Team (HF 3606). And finally appropriates \$480,000 for Community Health of South Florida - Pediatric Mental Health Crisis Stabilization Unit (HF 3248).

Description: Provides moneys for annual period beginning July 1, 2024, & ending June 30, 2025, & supplemental appropriations for period ending June 30, 2024, to pay salaries & other expenses, capital outlay—buildings & other improvements, & for other specified purposes of various agencies of state government.

Title: Community-based Mobile Crisis Intervention Services

Last Action Date: Died in Select Committee on Health Innovation. 2024-03-08

Summary: The bill creates Section 409.90637 of the Florida Statutes, which requires the Agency for Health Care Administration to provide coverage for community-based mobile crisis intervention services for Medicaid recipients. The agency is required to develop a plan for this coverage by January 1, 2025, and seek federal approval and waivers for the coverage

by a specific date. The agency must also adopt rules to implement and administer this section. The effective date of the bill is July 1, 2024.

Description: Requires AHCA to provide coverage for community-based mobile crisis intervention services for Medicaid recipients; provides duties of agency; requires agency to seek federal approval & waivers for such coverage.

Summary: This bill seeks to amend the Official Code of Georgia Annotated, which relates to the health of students in elementary and secondary education. The main provisions of the bill are as follows: 1. Requires all certificated public school personnel to receive annual training in suicide awareness and prevention. 2. Requires all public schools serving students in grades six through 12 to provide at least one hour of evidence-based suicide awareness and prevention training each school year, starting in the 2026-2027 school year. 3. Requires all public schools serving students in grades six through 12 to provide at least one hour of evidence-based youth violence prevention training each school year. 4. The Department of

Education, in consultation with the Department of Behavioral Health and Developmental Disabilities, will develop a list of approved evidence-based training materials for suicide prevention and youth violence prevention. 5. Requires the Department of Education to develop a model policy for student suicide awareness and prevention and provide relevant information to students and school personnel regarding anonymous reporting of dangerous activities. 6. Requires each local school system to adopt a policy on student suicide awareness and prevention and to sponsor a student-led student violence prevention club to sustain awareness activities related to suicide prevention and violence prevention

Description: A BILL to be entitled an Act to amend Part 3 of Article 16 of Chapter 2 of Title 20 of the Official Code of Georgia Annotated, relating to health of students in elementary and secondary education, so as to provide for evidence based suicide awareness and training programs; to provide for a definition; to provide for evidence based youth violence prevention training programs; to provide for student violence prevention clubs; to provide for local policies for anonymous reporting; to provide for an effective date; to repeal conflicting laws; and for other purposes.

Summary: This legislation mandates the Department of Law Enforcement to organize crisis intervention training for both state and county law enforcement agencies, as well as crisis intervention officers. The Department of Health is tasked with certifying these officers, and the bill outlines the definition of a "crisis intervention officer." These officers are granted the authority to order individuals deemed imminently dangerous to themselves or others to be transported to a specified behavioral health crisis center. The legislation also establishes new positions, acknowledges that the general fund expenditure ceiling is surpassed, and

Summary: This bill aims to establish a crisis intervention and diversion services program within the Department of Health in Hawaii. The program's purpose is to redirect individuals experiencing mental illness from the criminal justice system to appropriate healthcare services. The program would collaborate with law enforcement, courts, mental health providers, and the community. The department may lease or acquire a facility to operate a behavioral health crisis center to provide treatment and referral services.

Description: Establishes a Crisis Intervention and Diversion Services Program within the Department of Health to expand existing services to divert those with mental health issues to appropriate health care services. Requires the Department of Law Enforcement to coordinate crisis intervention training for state and county law enforcement agencies and training and certification for crisis intervention officers. Defines "mental health emergency worker" and "crisis intervention officer". Appropriates funds. Effective 7/1/3000. (HD2)

Summary: This bill aims to improve the state's programs for individuals with severe mental illnesses. The bill proposes several measures to achieve this, including, Requiring the Department of Health to track and publicly report data on crisis reports, emergency mental health transports, and court-ordered treatments, to review reports about individuals with severe mental illnesses who need assistance and assess whether they meet the criteria for assisted community treatment. If they do, the department will coordinate the process for an assisted community treatment order.

Description: Requires the Department of Health to track and publicly report certain data relating to crisis reports, emergency mental health transports, and court-ordered treatments. Requires DOH to respond to reports about persons having severe mental illness who are in need of assistance, assess whether those persons fulfill criteria for assisted community treatment, and coordinate the process for an assisted community treatment order if indicated. Establishes that a court's denial of a petition for involuntary commitment shall serve as notification to DOH that the person should be evaluated for assisted community treatment. Makes permanent sections 334-161 and 334-162, HRS. Declares that the general fund expenditure ceiling is exceeded. Makes appropriations. Takes effect 12/31/2050. (SD1)



Only if the Crisis Stabilization Unit does not have an available bed and there is no licensed medical facility or other suitable location should the respondent be retained in jail. The bill outlines the procedures for issuing a writ for taking a person into custody for evaluation by licensed medical professionals, the appointment of examiners, representation by an attorney, and the criteria for emergency retention for evaluation. It also allows for holding a person for up to seventy-two hours without a civil order if they pose a substantial likelihood of harm to themselves or others due to mental illness. The legislation specifies that if a person poses a threat to a minor child and

is held for treatment, the mental health professional must notify the Department of Child Protection Services before discharge.

Summary: This bill allows federal firearms licensees (FFLs) to enter into agreements with firearm owners to hold their firearms for safety purposes. The agreement would involve the FFL taking possession of the firearm, storing it for an agreed-upon period of time, and returning it to the owner according to the terms of the agreement. The bill also directs the Oregon Health Authority (OHA) to develop and distribute a firearm suicide prevention pamphlet, based on evidence-based practices, to reduce the risk of firearm suicides. Under the bill, a person may not bring a cause of action against an FFL for any act or omission related to entering into a firearm hold agreement, unless the action is based on negligence or unlawful conduct. The existence of an individual firearm hold agreement may only be disclosed by the FFL pursuant to a warrant or subpoena. The bill takes effect on the 91st day after the date on which the 2024 regular session of the Eighty-second Legislative Assembly adjourns sine die. The impacted industry would be federal firearms licensees, who would be able to offer the service of holding firearms for safety.

Description: Digest: The Act allows FFLs to enter into agreements to hold guns for safety. The Act also directs OHA to develop a firearm safety pamphlet. Description: Present law requires that if, and only if, a service recipient has communicated to a qualified mental health professional or behavior analyst an actual threat of bodily harm against a clearly identified victim, and the professional, using reasonable skill, knowledge, and care ordinarily possessed and exercised by the professional's specialty under similar circumstances, has determined or reasonably should have determined that the service recipient has the apparent ability to commit such an act and is likely to carry out the threat unless prevented from doing so, then the professional is required to take reasonable care to predict, warn of, or take precautions to protect the identified victim from the service recipient's violent behavior. This bill requires that if, and only if, a service recipient has communicated to a qualified mental health professional or behavior analyst an intent for actual threat of bodily harm against a clearly identified victim, or an intent for actual threat of bodily harm against a group of people, including, but not limited to, students at a day care or school, people at a place of worship, and members of the service recipient's family, and the qualified mental health professional or behavior analyst, using the reasonable skill, knowledge, and care ordinarily possessed and exercised by the professional's or analyst's specialty under similar circumstances, has determined or reasonably should have determined that the service recipient has the apparent ability to commit such an act, then the professional or analyst is required to do the following: (1) The professional or analyst must take reasonable care to warn of or take precautions to protect the identified victim or

group of people from the service recipient's violent behavior; and (2) The professional or analyst must report the threat to either the local law enforcement agency with jurisdiction over the municipality or county of residence of the service recipient, or, if the threat is general and not imminent or clearly identified, the local crisis response service. This bill provides that a professional or analyst who acts or makes a reasonable attempt to act in accordance with this bill is not liable for damages in a civil action, subject to prosecution in a criminal proceeding, or subject to disciplinary action by a regulatory board for such act or reasonable attempt to act. ON FEBRUARY 22, 2024, THE HOUSE ADOPTED AMENDMENT #1 AND PASSED HOUSE BILL 1625, AS AMENDED. AMENDMENT #1 adds that the qualified mental health professional or behavior analyst must not only determine, or reasonably should have determined, that the service recipient has the apparent ability to commit such an act, but that the service recipient is also likely to carry out the threat unless prevented from doing so. ON MARCH 28, 2024, THE SENATE SUBSTITUTED HOUSE BILL 1625 FOR SENATE BILL 1673, ADOPTED AMENDMENT #1, AND PASSED HOUSE BILL 1625, AS AMENDED. AMENDMENT #1 adds that inpatient hospitalization of the service recipient discharges the duty to warn imposed on a qualified mental health professional or behavior analyst by state law.

The board must do the following: (1) Develop and recommend a comprehensive statewide behavioral health crisis intervention services plan and annually review and update the recommended plan. The board must submit the recommended plan no later than December 31, 2024, and by each December 31 thereafter, to the governor, the chair of the health and welfare committee of the senate, the chair of the health committee of the house of representatives, and the legislative librarian; (2) Within three years of the initial convening of the board, and every three years thereafter, review the provision of crisis intervention services in this state, the system of care of crisis intervention services in this state, and the crisis intervention services needs of residents of this state, and make a written report of the board's findings and recommendations. The board must submit the report not later than December 31 of each year that it is due to the governor, the chair of the health and welfare committee of the senate, the chair of the health committee of the house of representatives, and the legislative librarian; and (3) Report on each expenditure made under the fund in the previous fiscal year and to what extent the expenditure accomplished the intended purpose of the expenditure and make recommendations, consistent with the purposes for expenditures under this part, for appropriating moneys expected to be received in the next fiscal year. The board must submit the recommendations no later than December 31, 2024, and by December 31 each year thereafter, to the governor, the chair of the health and welfare committee of the senate, the chair of the health committee of the house of representatives, and the legislative librarian. This bill provides that the board is composed of the following 11 members: (i) the comptroller of the treasury or the comptroller's designee, (ii) the commissioner of commerce and insurance, or the commissioner's designee, (iii) the president of the Tennessee Association of Chiefs of Police, or the president's designee, (iv) the director of the department of mental health and substance abuse services, or the director's designee; (v) the director of TennCare, or the director's designee, (vi) three members, appointed by the governor, each of whom is either a current director of an emergency communications district or a current member of an emergency communications district board of directors at the time of their appointment, who must each reside in a separate grand division of the state, (vii) one member, appointed by the governor, who is a qualified mental health professional who provides crisis intervention services, (viii) one member, appointed by the governor, who is a representative of a behavioral health treatment program providing crisis intervention services; and (ix) one member, appointed by the governor, who is a certified peer recovery specialist. This bill provides that initial appointments must be staggered. Members must not be selected to serve on the board for more than two successive terms. This bill requires the board to elect a chair and other officers as it may deem necessary and appropriate. The

officers must be elected for two-year terms. The board must meet quarterly, and at the call of the chair. A quorum consists of six or more members; and all official action of the board requires a quorum. Any member of the board who fails to attend at least 50 percent of the regularly scheduled meetings of the board within any 12-month period must automatically be removed from the board and a successor member must be appointed by the appointing authority to serve out the remaining term of the member being replaced. FUND This bill creates a fund within the state treasury, known as the "Behavioral Health Crisis Intervention Services Fund," to support the operation and maintenance of the behavioral health crisis intervention services system known as the 988 Suicide & Crisis Lifeline, and the continuum of behavioral health services. The board must administer the fund, and all expenditures from the fund are subject to review and audit by the comptroller of the treasury. This bill provides that moneys in the fund may be expended for (i) establishing, operating, maintaining, and improving 988 or crisis intervention services; (ii) establishing, operating, or contracting for crisis teams; (iii) recruiting and retaining qualified personnel; (iv) providing specialized training related to serving at-risk communities; (v) raising public awareness of 988, behavioral health crisis intervention services available in this state, and education on behavioral health conditions; (vi) data collection and analysis, reporting, evaluation participation, and related quality improvement activities; (vii) administration, oversight, and evaluation of the fund; and (viii) reimbursement of money appropriated by the general assembly to implement this part.SURCHARGES ON RESIDENTIAL, BUSINESS, AND WIRELESS SERVICE This bill provides the fund must be funded by means of a behavioral health crisis intervention services surcharge of 60 cents per month imposed by providers on subscribers of telecommunications services in this state. The surcharge must be imposed by (i) each provider providing residential telephone service on all residential subscribers per residence exchange access line in this state, (ii) each provider providing business telephone service on all business subscribers per business exchange access line in this state, (iii) each wireless provider on all wireless service customers for each wireless telephone number for which the wireless service customers are billed by the provider, and (iv) each provider of nontraditional communications service on subscribers of such services where the provider is required to or opts to provide 988 service. This bill requires a provider to impose the surcharge on the person purchasing the service and to collect the surcharge on behalf of this state. The surcharge collected by a provider is not subject to taxes or charges levied by the state, or any political subdivision of the state, and the surcharge is not considered revenue of the provider for any purpose. Each provider imposing the surcharge must state the surcharge as a clearly identifiable, separate item on all subscriber invoices rendered on or after the effective date of this bill. The surcharge does not apply to wholesale services or to a state government entity. This bill requires the surcharge to be collected by providers from subscribers to telecommunications service with each invoice for service and must be paid by providers on a monthly basis to the department of finance and administration no later than the last day of the month following the surcharge's collection. The surcharge must be deposited into the fund on a monthly basis and must be used to support the implementation and long-term solvency of behavioral health crisis intervention services in this state, as well as reasonable and necessary administrative and operational expenses of

the board and fund. Each provider collecting the surcharge is entitled to recover the actual incremental costs of billing, collecting, and remitting the surcharge. However, a provider collecting the surcharge is not responsible for uncollectable surcharges. Each provider collecting the surcharge is fulfilling a governmental function and in so doing is immune from suit for damages of any kind and is not liable for refunds except to the extent that the provider has failed to collect or remit surcharges to the fund.BEHAVIORAL HEALTH CRISIS INTERVENTION SERVICES PLAN This bill requires the board to develop and recommend a plan for establishing, operating, and maintaining a behavioral health crisis communications center, which must receive calls from individuals experiencing a behavioral health crisis or persons requesting assistance for an individual in crisis, provide appropriate crisis intervention services, deliver quality coordination of behavioral health crisis care, and conduct follow-up to ensure appropriate connection to treatment and services. The plan must include recommendations as described in the bill. RULEMAKING This bill authorizes the department, in collaboration with the department of finance and administration, to promulgate rules to effectuate this bill.
